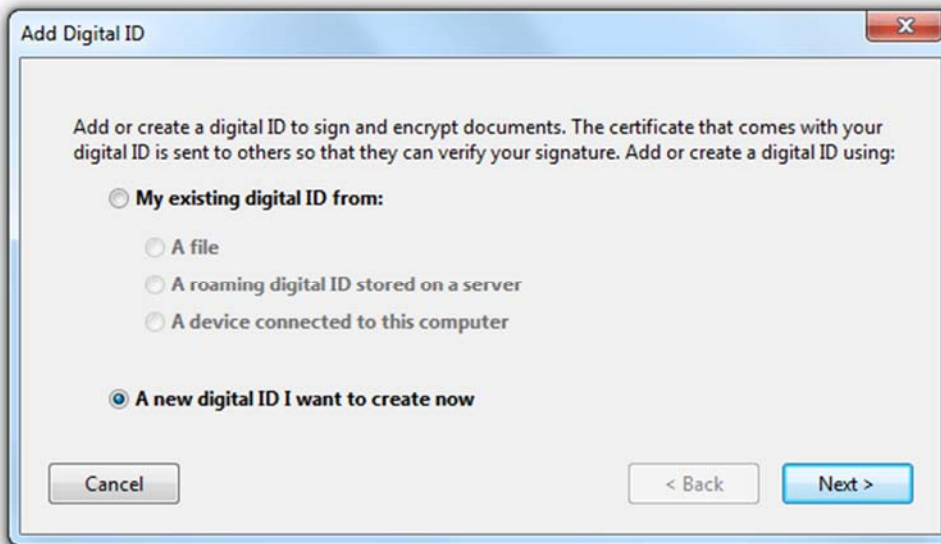


Form Completion and Submission Instructions

Form Completion

1. **IMPORTANT:** The following steps are only needed if you will be sending the document electronically. It will likely take you longer to read the instructions than it will to implement them. If you are completing the forms online then printing, hand signing and mailing them ***the following does not apply to you.***
2. To “sign” the form click in the signature field which will cause the following popup to display.



3. Unless you happen to have an existing digital ID select the second option as shown above and then click the Next button.
4. This will replace the popup above with another (shown immediately below). The simplest option is to select the top option of the two as shown and then click on the Next button.

5. This will again replace the popup with another that you'll use to actually create your digital ID. Enter your full name, leave the Organizational Unit and Organizational Name fields empty and then enter your email address. Leave all of the other options set at their default values and click the Next button.
6. You'll then be provided with the location of the digital signature file that you just created and will be prompted for a password and then you'll need to confirm the password. Once you have done so click on the Finish button.
7. You should then be returned to the document you were working with and a popup should display asking that you enter the password for the digital signature file that you just created. Enter the password, leave everything else set with the default values and click on the Sign button.
8. You will be prompted to save the file and after doing so you should make note that the signature field has been completed with your new digital signature.

Using the Form "Submit" Button

Complete steps 1 – 8 above (you may also wish to save the form at this time). At the bottom of the form that you'd like to submit click on the green "Submit" button and follow the instructions provided. IMPORTANT: The success of this method is highly dependent upon a number of variables. If you are having trouble with it we suggest that you use the "Saving a Digital Copy and Attaching to an E-Mail" method above.
